- B1. The Demolition drawings identify areas that are not included in the Electrical drawings. Is this an oversight or is the electrical contractor responsible for determining what the scope of the work is? For example, if tile is being removed from walls by the demolition contractor, what is the electrical contractor's liability, how is this to be quantified for establishing a common unit of measure for all bidders? Contractor shall reference drawings for exact work. The demolition contractor shall be responsible for items broken or damaged during construction.
- B2. Several locations on the demo drawings call for fixtures to be removed and reinstalled in the same place. Can they be covered for painting in lieu of removal, who would be responsible if an existing fixture failed after reinstallation? No, fixtures shall be removed and reinstalled per drawings.
- B3. Sheet E002 shows a feeder schedule, are these feeders' part of this project? Whatever feeders are needed to complete the project. The feeder schedule is for reference.

B4. Demolition notes call for the complete removal of existing lighting, exit signs, receptacles, telephone, data, security, etc. including all conduits back to the source. Other notes call for the EC to be responsible for ensuring the existing
